Case # 1

- Lisa and Jack had only been dating for a couple of months.
- Lisa had a son from previous relationship.
- After knowing each other a week, Jack started moving his items into her home.
- Jack started monitoring her phone, taking her keys so she couldn't leave home, and she eventually lost her job.
- The physical abuse began within a month.
- Jack was a heavy drinker and refused to let Lisa drive her and her son home from museum.
- Jack began accusing Lisa of cheating on him with ex-boyfriend and when he passed ex-boyfriends house on the way home from museum, he start driving reckless.
- Lisa then called police.
- Jack grabbed phone and threw it out the car window. He then began hitting Lisa with the back of his hand and forearm.
- Jack pulled over and then got on top of her in the passenger seat punching her in the face until she blacked out.
- Last thing she remembered, her son was trying to get out of the car seat.

Case # 1 (continued)

- Lisa woke up and Jack was getting out of the car. She saw him throw her keys
 into the nearby field.
- Lisa's son was still in car seat, but he now had a large red mark across his cheek.
- A passing car had stopped, and the couple called the police.
- Jack left before Police and EMS arrived.
- The last thing Lisa remembered was her son screaming and trying to get out of his car seat.
- Lisa told the story to the Officer and her son added, "he choked you mommy!"
- Lisa didn't remember Jack choking her.
- The Officer took Lisa and her son to the magistrate's office for an assault and battery charge against Jack.
- When the magistrate saw Lisa's face, Jack was charged with malicious wounding, which LEO authorized, and an emergency protective order (EPO) was issued.
- Jack was also charged with assault and battery for hitting Lisa's son based on the boy's statement.
- The magistrate also charged Jack for assault and battery for hitting Lisa's son based on the boy's statement.



Officer Melissa Cohen, Narrows Police Dept.

- Dispatch EMS & Encourage Lisa to see Forensic Nurse Examiner (FNE)
- Prompt Lisa's son to be seen by EMS and FNE
- Broadcast a full description of Jack to ALL Law Enforcement to "Be On the Look Out" and Apprehend when found
- Immediate pictures of injuries to Lisa and son be taken
- Use Child Forensic Interviewers for Lisa's son
- Pull camera footage from museum and any cameras with correlation with Lisa's version of events
- Offer continued support to Lisa and son through process



April Bennett, Forensic Nurse SAFE Center of SWVA

- Meet medical and legal needs of patients- both Lisa and her son.
- Request emergency advocate to provide support to the patients during and exam.
- Assess emergency conditions, identify physical trauma/findings and possible evidence, have patients evaluated for strangulation and radiology testing, evaluate psychological needs, collect evidence including photos, provide follow-ups/referrals.
- Report suspected child abuse as required (Code of VA) to local CPS and Law Enforcement.
- Strangulation With patient consent (Lisa) report to law enforcement and use a Trace Evidence Collection Kit (NFK) and notify law enforcement kit was used per Code of Virginia, § 19.2-11.7 (as of July 21, 2025). For Lisa's son, this would be a mandatory report.
- Safety Planning before discharge including Danger Assessment.
- Further documentation.

Action Steps

- **Court Advocacy**
 - Assistance for filling protective order
 - Court accompaniment for legal proceedings and law enforcement interviews
 - Assistance in filing paperwork for child custody, support and visitation
 - Help with navigating justice system
 - Referrals to appropriate partners, when needed to Legal Aid and other agencies
- **Emergency Services**
 - **Emergency Shelter**
 - 24-hour info., referrals, and intake hotline
 - Safety Planning
 - In-person crisis response
- Victim and Survivor Support
 - Allow Victims to discuss empowerment, self-esteem, coping skills, healing, and more...
 - Offer bi-weekly support groups
 - Individual counseling

- Have you left him after living together during the past year?

- Has he ever used a weapon against you or threatened you with a lethal weapon (If yes, was the weapon a gun?

- Has he avoided being arrested for domestic violence

- Pull interview from LEOs
 - Review complete record of all officers and witnesses present at the scene
 - CRUCIAL to have phone numbers and other contact info for all witnesses (multiple safe contact numbers are useful)
 - All witnesses should be interviewed separately if possible
- Confirm that LEO has scheduled forensic interview with the child
 - Attend interview to assist with follow up questions
 - Provide advice to LEO regarding follow up investigation issues
- Prepare for bail hearing work with VW to contact witnesses and consider special conditions
- Trial Preparation
 - Ensure that LEO has documented EVERYTHING. All statements, both inculpatory and exculpatory must be preserved.
 - Consider other sources of evidence regarding time frames cameras, phone evidence, efforts to locate defendant, levels of intoxication, statements made from defendant, and jail phone calls
 - Ensure that all witnesses have been subpoenaed
 - Consider options to resolve cases and discuss with LEO, victim, and defense counsel. ("What are we trying to accomplish?")

- Info. and Navigation Provides info. about court procedures, case status, and the overall criminal justice process
- Emotional Support Crisis Intervention, emotional support and counseling
- Courtroom Assistance Could be a courtroom tour, accompany victims to court and offer support during trial
- Referrals Connect victims with various social services, including counseling, medical and other resources
- Safety Planning See document and further provide info. about protective orders
- Financial Assistance Crime Victims' Compensation Fund
- Restitution Seek restitution from offenders
- Interpreter Services Help victims access court-approved interpreters
- Victim Impact Statements Guidance to prepare victim impact statements
